

# **Qualys Cloud Agent Linux 2.6.0 (x64) / 2.6.2 (ARM)**

May 2020 (Updated on 29 September 2020)

We're excited to tell you about new features, platform coverage changes, improvements, and bug fixes in this Cloud Agent release. These updates are specific to the agent binary. Qualys Platform backend, UI, and API updates for new features and fixes of management and reporting capabilities of Cloud Agents are documented in the Cloud Suite release notes and may be released on a separate schedule.

#### **New Features**

The following new features are available in this release:

- Client-side initiated "ScanOnDemand" function
  - This feature is used to trigger the agent to initiate an on-demand collection of the asset's metadata for supported activated modules: Vulnerability Management, Policy Compliance, and Inventory
  - o Refer to the Cloud Agent Linux Install Guide for description of this feature
- Support for instances running AWS EC2 ARM processors
  - o Including AWS Graviton2-based EC2 instances M6g, C6g, and R6g
  - This requires the deployment of a processor-specific installer and binary, Cloud Agent Linux 2.6.2, developed explicitly for ARM processors

#### **Enhancements**

The following enhancements are available in this release:

- Multiple proxy servers are now supported allowing for failover proxy servers
  - o Refer to the Cloud Agent Linux Install Guide for description of this feature
- Added support for File Integrity Monitoring on Red Hat Enterprise Linux 7.6, 7.7, 8.0, 8.1,
   CentOS 8, SUSE Enterprise Linux 15, Ubuntu 19.04, 19.10, and Oracle Enterprise Linux 8.0, 8.1
- Added support for Policy Compliance UDC File Content Check multi-line regex and max file size limit
  - PCRE2 library is bundled with the standard Cloud Agent Linux distribution to support this feature
- Added support for Policy Compliance UDCs on Red Hat Enterprise Linux 7.7, 8 and openSUSE 15 operating systems
- Updates to libraries utilized by Cloud Agents as follows:

- Curl bundled library upgraded
- o OpenSSL bundled library upgraded
- o Poco bundled library upgraded
- SQLite bundled library upgraded

### **Behavior Changes**

The following behavior changes are in this release:

- This release adds parallel uploads of supported application scan results (Vulnerability, Policy Compliance, and Inventory) for agents activated with multiple apps. This improves performance in cases where one scan delta upload will not impact the upload of another scan delta.
- Certain agent operating status log file entries were reclassified from Information to Debug
  increasing the number of days referenced in each log file and archive for agents set with
  Information log level in the agent's Configuration Profile.
